## 1. Objective of the Policy:

- Prohibition of bribery (any gift, payment, consideration, financial or non-financial advantage or benefit of any kind that constitutes a corrupt and illegal practice.

## 6.2 Respect for Human Rights, Labor Rights:

Suppliers are required to respect human and labor rights in their business activities and to establish a safe working environment.

Suppliers are required to comply with the following parameters, the following practices are prohibited:

- forced labor (including slave labor),
- human trafficking,
- inhumane treatment of workers.
- · child labor, and
- discrimination.

All workers must work under fair labor conditions and standards, in terms of wages and working hours, and the rights of workers to form or join trade unions must be respected.

All workers must work in a safe and healthy working environment.

Suppliers must comply with applicable safety standards in all countries and regions where they operate.

### 6.3 Environmental Protection:

Suppliers are expected to embrace environmental protection as a high priority issue, and to actively engage in producing goods in an environmentally friendly manner, and also supplier are encouraged to adopt

- Environmental management systems.
- Procure parts and materials in such ways that have the smallest negative impact on the environment, such as reducing air pollution or eliminating use of potentially hazardous substances, and reducing greenhouse gasses as well landfilling of waste, preserving biodiversity in the areas of operation;

### **6.4 Conflict Minerals:**

Unitech Plasto Components ensures that our products do not contain Conflict Minerals that have been sourced from mines that support or fund conflict within the Democratic Republic of Congo or adjoining countries and CAHRA (Conflict Affected and High-Risk Areas).
